NEW BUSINESS

Mr. Bennett gave an Administrator's Report. He updated the Board concerning recent meetings with employees to initiate the first 30 days of the furlough program, which will permit employees to remain on the Town's health insurance and file for unemployment. He also reported that the Town has seen a rise in COVID cases and that the Town continues to work with St. Clare's in vaccinating as many of our seniors.

He also reported on the budget process, the roof replacement of the Municipal Building and that following the project the building will be power washed to improve the outside appearance.

Mr. Bennett also announced that the We Love Dover campaign will hold town cleanups in April. On April 10th, Wards 1 and 4 will be done and on April 17th Wards 2 and 3 will be completed.

Administrator Bennett also reported that the Town has been holding meetings with Superintendent of Dover's school system to collaborate on issues of mutual interest and that the school will be opening its track at East Dover Elementary School on April 1st which will be open to the public. He also reported that he has had meetings with the DPW Superintendent to review the conditions of parks in Town following a safety report from the JIF. There is much work that needs to be completed and the Town is currently seeking prices to repair and improve the basketball courts at Crescent Field. The Town is also working to repair and in some cases replace playground equipment.

Administrator Bennett also reported registration for the soccer program will being on Friday. that he has been working with Alderman Quinones to getting the soccer program restored in Town.

Mayor Blackman stated that a lot of people have expressed interest in the Community Garden and believes it will be a good thing for Dover. The Mayor also provided an update on the Easter Egg Hunt (Handout) in the Crescent Field Parking Lot, which will be for children ages 2 to 10 years old. The event is a partnership between the Town of Dover and Table of Hope. The Mayor also stated that the Easter Bunny will be coming this year.

Deputy Chief Delaney spoke about the reopening of the schools and the hiring Class III officers as well as two programs the Department will be participating in, which is the Distracted Driving Program and Pedestrian Safety Program. He also reported that officers are attending training for mental health.

Chief Code Enforcement Bill Isselin stated that with the start of spring, code enforcement will be conducting inspections around Town. The Mayor also reported that there will be an upcoming meeting for the 300 Anniversary Committee.

Mr. Velasquez spoke about Cannabis which is legal. Towns have 120 days to opt in and opt out.

He spoke about micro-cannabis business and his support.

Speaker: Marina Redmond **Address:** 3 Borough Square

Municipality/County: Sayreville / Middlesex County

Ms. Redmond spoke about medical cannabis and how it has helped her. She hopes to see it in

Dover / Morris County.

Speaker: Jeffrey King

Address: 24 Elizabeth Parkway

Municipality/County: Eatontown / Monmouth County

Mr. King stated that this was his first time addressing a public body and speaking. He spoke

about his support of Cannabis.

Speaker: Chris Almada **Address:** 159 Mt. Hope Ave.

Municipality/County: Dover / Morris County

Mr. Almada stated the he grew up in Dover. He was happy to hear about the basketball courts getting redone. He also stated that he appreciated the mental health training the police are receiving. He also spoke about an accident he was involved in and how medical marijuana has helped him and spoke in support of Cannabis.

Speaker: Lefty Grimes with Sativa Cross

Municipality/County: East Hanover / Morris County

Mr. Grimes spoke about the fact that there is no dispensary for Cannabis in Morris County and that there needs to be a medical dispensary. He spoke of his support of Cannabis and wheel chair access.

Speaker: Uma Dhanabala **Address:** 777 Concord Ave.

Municipality/County: Cambridge, Massachusetts

Ms. Dhanabala is a doctor who practices in Massachusetts and is originally from New Jersey. She spoke about her background and advocacy for Cannabis. Dr. Dhanabala has written prescriptions for medical marijuana as treatment for ages 4 to 98 years old at all stages of life. She hopes the Board will support Cannabis.

Speaker: Hugh Giordano **Address:** 57 Argyle Ave.

Municipality/County: Gloucester Township / Camden County

Mr. Giordano us with UFCW Local 152 which has 1.4 million members. It is the official union of cannabis workers. He spoke about labor issues with cannabis and the salaries which it could support.

Speaker: Jaime Van Sciver **Address:** 427 Greenwich Ave.

Municipality/County: Paulsboro / Gloucester County

Ms. Van Sciver shared her story using Cannabis and spoke in support of Cannabis.

Speaker: Antonio Acosta **Address:** 130 Madison Street

Municipality/County: Dover / Morris County

Mr. Acosta commended those speakers who spoke and shared stories. He also appreciated the report by the Administrator and was happy to hear about discussions and improvements with the parks. He also spoke about COVID-19 and the rise in cases and the fact our kids are still not back in school. He asked the Mayor to relook at the bar curfew being 2:00a.m. He also asked the Mayor if the Shade Tree Commission would be planting trees this Spring and stated we are lacking trees in the Town. He also commented about the look of our new police cars bringing us into the new century.

Mayor Blackman stated that she will speak with the Shade Tree Commission and she knows they are looking at planting some trees as some trees had to be taken down. Alderman Ballesteros, who is the Liaison to the Shade Tree Commission stated that there will be a planting for Arbor Day with a location to be determined. Alderman Ballesteros also stated that the Town has received Tree City USA designation. Ms. Van Sciver shared her story using Cannabis and spoke in support of Cannabis.

I have reviewed the Town of Dover webpage, gone to the schedule of meetings section, and the Planning Board and the Board of Adjustments have not listed an Agenda or Minutes since at least March 2019 and the Town of Dover, Mayor and Board of Aldermen, last minutes posting was December 21, 2020.

Acting Municipal Schmidt addressed the comment where the minutes of the Board of Aldermen can be found. Last year the Town starting using its ECode page which is more user friendly. Mr. Schmidt also commented that the Planning Board and the Board of Adjustment are separate public bodies and that question would need to be directed toward them. There was a brief discussion on the Board Agenda and Minutes postings.

Mayor Blackman thanked everyone who spoke about Cannabis and stated that the Municipal Attorney is reviewing items and will be making a recommendation to assist the Town as to marijuana. The Mayor also stated that the 300 Committee held its first meeting to discuss ideas and suggestions.
