AGENDA ITEMS:

ORDINANCE(S) FOR INTRODUCTION

1. Ordinance #31-2008 Right of Way Discontinuance by Morris County to the Town of Dover (Section So. Salem St)

Mayor Dodd asked the Attorney to provide an explanation of Ordinance #31-2008. Attorney Pennella explained that there was a project on So. Salem Street that caused the road to be aligned a little bit off where it had been in the past and because of this there was a small triangle of property along South Salem Street that went across three or four different properties. It actually went to the property that Chafin Home Builders purchased and developed a house. As part of the planning process, there was an extra lot to be added there and part of this property will go to that lot to make it a full lot as well as properties going further south on Salem Street. Since, this is a county road the county has two mechanisms to relieve themselves of the obligation of a roadway. One method is through a street vacation which the municipality passes but they can also do a discontinuance which can be done by resolution. The discontinuance is what the town has chosen to do. The Board of Chosen Freeholders passed a resolution indicating they are discontinuing the portion of the roadway as described in the map. As a result of the resolution from the Board of Chosen Freeholders it gets turn back to the municipality. The municipality has no use for a small sliver of land (triangle shaped). In turn to make it clean and make the plan go forward, that the planning board approved we are now vacating that small strip of land in front of those properties.

Aldermen Visioli wanted to clarify that this land is on the east side of Salem Street, under the bridge, down three lots. Attorney Pennella confirmed the location.

REGULAR MEETING MINUTES October 14, 2008

The Regular Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

The meeting was called to order by Mayor Dodd at 7:06 pm

ROLL CALL

Present: Aldermen Delaney, Poolas, Visioli, Donofrio, Picciallo, Timpani, Romaine and Mayor Dodd Absent: Alderman Fahy

Also present were Attorney Pennella and Clerk Verga

Clerk Verga stated adequate notice was given to the official newspaper.

Mayor Dodd opened this portion of the meeting to the public for agenda items only. Seeing no hands and hearing no voices this portion of the meeting was closed.

Mayor Dodd's Report – Mayor Dodd attended several meetings which included many personnel meetings. Mayor Dodd and Aldermen Picciallo attended an event at Dover Child Care Center for their 40th Anniversary Celebration. He requested a proclamation be presented to their organization. He also attended a Water Commission meeting to discuss the water system in the Town of Dover and the possibility of creating a capital plan for the next 5 to 10 years in addition to the DPW & Water Department merge. Mayor Dodd thanked New Jersey Department of Transportation for the paving of the Route 46 Bridge. The bridge construction is underway and it should be about a three year process. He noted that there are about five planned detours throughout the process. He met with representatives of the College of New Jersey which has received funding from NJDOT to perform a form base planning in municipalities. Dover has been chosen to have the College of New Jersey perform a form base planning in municipalities as in need of rehabilitation. The three areas are 3, 5, and 7 in the Dover Train Station area, Crescent Field lower lot and Blackwell Street area. Mayor Dodd looks forward to working with them in providing this plan which is free of charge to Dover taxpayers. Mayor Dodd and a few of the Aldermen attended the Firemen's Inspection Dinner and he commended the Fire Department for their hard work. He noted their equipment had to be outside while the floors were being done and equipment was immaculate. We have a lot to be proud of for the work the Fire Department provides for the community. Mayor Dodd also attended the ceremony for the Share of Hope Walk (Hope House).

ALDERMEN/COMMITTEE REPORTS -

Alderman Fahy – Absent

Alderman Picciallo – During the past two weeks, Aldermen Picciallo attended various personnel committee meetings. He attended the inspection and feels our Fire Volunteers deserve a lot of credit and they should be recognized. He also attended Dover Child Care 40th Anniversary celebration and he wishes them much success in their fundraising efforts. NJ Transit had a court date on October 7th regarding the Crescent Field yard and they wanted the court case dismissed. However, they have a trial date on November 13th. Alderman Picciallo was notified today by Mr. Isselin that NJ Transit has started to repair the roof and they are painting the building. Mr. Isselin is in contact with NJ Transit to hopefully have the yard cleaned up.

Alderman Poolas – Alderman Poolas received a complaint from a resident on Pequannock Street regarding the wall that fell down and went over the sidewalk. Alderman Poolas met with Property Maintenance and the wall and steps are being worked on today by the property owner. The Memorial Association is requesting photos of Veterans so that they can be placed on display in the hallway.

Alderman Donofrio – Alderman Donofrio thanked the Shade Tree Commission and Department of Public Works for the removal of the tree on Audrey Place. He attended the Hope House Walk this past Saturday.

Alderman Timpani – Alderman Timpani noted that all the street lights on Blackwell Street are working and the JFK Park lights will be working by tonight or tomorrow. The project on Lynn, Trenton, Dewey and Belmont is complete and it looks very good.

Alderman Delaney – Alderman Delaney attended several meetings which included Board of Education and Courts. He received several resident complaints that were handled.

Alderman Visioli – Alderman Visioli noted that the personnel committee has been meeting and they have honed in on an individual to be the Municipal Department Head of DPW and the Water Department. The personnel committee believes that the individual should also be part of the merge (DPW & Water). He also noted that the search continues for a Town Administrator. Public Works Department worked to repair a water valve that was stuck in the open position on the south side of town and that area was without water. Alderman Visioli has looked into the reverse 911 system so that people in the affected areas could be notified of the problem. He will gather information about the system and will provide a report at a future meeting.

Alderwomen Romaine – Alderwoman Romaine has no report other than the personnel committee has had several meetings.

Attorney Pennella's Report – There has been no change in status of litigation since the last meeting.

ORDINANCE(S) FOR INTRODUCTION

ORDINANCE 31-2008 AN ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER, COUNTY OF MORRIS, STATE OF NEW JERSEY VACATING A PORTION OF SOUTH SALEM STREET

WHEREAS, by a Resolution adopted by the Morris County Board of Chosen Freeholders at their September 24, 2008 regular meeting, such Board declared that a portion of South Salem Street situated in the Town of Dover, County of Morris and State of New Jersey had been discontinued as a county road and returned to the jurisdiction and control of the Town of Dover; and

WHEREAS, the portion of the roadway discontinued is not needed by the Town of Dover for the public purpose of a roadway;

NOW, THEREFORE, be it ORDAINED by the Mayor and Board of Aldermen of the Town of Dover, Morris County, New Jersey as follows:

1. The portion of South Salem Street in the Town of Dover, County of Morris and State of New Jersey described in the attachment entitled "Metes and Bounds Description Discontinued Right of Way Strip, South Salem Street (C.R. 665), Town of Dover, Morris County, New Jersey" is hereby vacated, such attached description being in accordance with a map entitled "South Salem Street Bridge Replacement Approach Realignment – County Discontinuance Area," dated April 24, 2008, prepared by James A. Baker, P.L.S., 209 Eyland Avenue, Succasunna, New Jersey.

2. There is hereby reserved an easement upon the vacated portion of roadway for all utilities, including but not being limited to electric, gas, sewer and cable television; and

3. All ordinances or parts of ordinances inconsistent with this within ordinance are hereby repealed to the extent of such inconsistencies.

4. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

5. The Ordinance shall take effect in accordance with law.

<u>Robin Foster</u> – 90 Penn Avenue – Mr. Foster attended the trip to Cape Cod which was sponsored by the Recreation Commission. Alice Gilbert did a wonderful job with the trip. He noted the great weather, great bus and that a good time was enjoyed by all.

<u>Matty Barrett</u> – 107 Bassett Hwy. – He noted that construction has started on Route 46 bridge project and in the process they had to push back towards the river, roadway for additional space. They took down a barrier fence that Traveler's Diner had installed in the parking lot. They cut down trees on top of the hill and then they had a core excavator to remove the roots of the trees. In the process, they pushed debris, rock, and dirt over the edge. He complained to the operator and he received no response. The project manager was contacted by Michael Hanston however there also has been no response. He contacted several agencies like the Rockaway River Water Shed Association, Soil Conservation, and NJDEP to let them know about the debris which can knock down trees and enter the Rockaway River but he has not received any response. Mayor Dodd noted that it seems that Mr. Barrett took the appropriate steps however because it's a state contract the there's not much the town can do in that perspective. Mayor Dodd noted that he would place a call to Alex to let them know there's a concern.

Connie Sibona-Foster – 90 Penn Avenue – Mrs. Foster explained that there's no traffic light for pedestrians to cross at

Warren/Route 15 & Pequannock Street. Mayor Dodd explained that it's being discussed with the new cul-de-sac in front of Charlotte's Web and PJ Plumbing and with the Bassett Hwy. project a traffic light will probably be eliminated.

Jon Sperry - 58 No. Essex Street – There's a small number of kids with skateboards and bicycles that defy traffic. The kids are riding there skateboards and bicycles up to the front door of his shop. He talked with the kids however some understand and others don't. The kids use the handicapped ramp at the library and in and around JFK Park. He explained that someone will get hurt and then it will become the town's problem. He wants some enforcement from the police department so that it doesn't become a town problem.

<u>Bill Hann –</u> 90 E. Munson – He publicly thanked the board that worked diligently for keeping his taxes down. He noted that his taxes increased a tiny bit considering we lost money from the state, salaries and pensions have increased. He fishes throughout the Town of Dover and believes the River Walk is a wonderful idea however the only one that uses this area is the homeless for sleeping and bathroom use. Alderwoman Romaine noted that the project was through the soil conservation group which was funded by them and they brought people and groups to do the planting. However, once they cut back on there funding it was up to the town to continuously maintain the project but unless you have someone there everyday it's difficult to maintain. Alderwoman Romaine noted that funding should be looked into so people may enjoy this area.
