#### CAUCUS MEETING MINUTES November 10, 2008 7:00 PM

The Caucus Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

Mayor Dodd called the meeting to order at 7:00 pm

All joined in the Pledge of Allegiance to the Flag and prayer was given asking for guidance and strength to do what is right for our town and our citizens.

Alderman Poolas wanted to know if Ms. Edith Vargas' concern (#11) had been rectified. Clerk Verga explained that the library is looking into getting the painting restored. Alderman Picciallo explained that they are looking into a new frame to put on the painting.

#### **AGENDA ITEMS:**

#### ORDINANCE(S) FOR INTRODUCTION

1. Ordinance #33-2008 Salary Ordinance for FMBA

Mayor Dodd explained that the above ordinance is authorization of the agreement between the Town and Local 60 FMBA. He explained that it was a long negotiation period (2yrs). Through some very difficult negotiation, Mayor Dodd feels that it's a win-win for both parties. Mayor Dodd commended Alderman Delaney for chairing the committee. Mayor Dodd noted that we should recognize that many communities are going through difficult financial times and for many years life health benefits have been a perk that town employees have received. However, in this contract it eliminates life time health benefits for new hires. Mayor Dodd believes it's a mile stone that the Town of Dover is trying to achieve in saving taxpayers money in addition to other items that were negotiated.

Alderman Delaney explained that it's a contract that has been in the works for the last 2 years, a lot of meetings back and forth. Alderman Delaney is very pleased with the contract and he feels it's fair all the way around for both sides and he hopes the board considers approving it tonight.

#### ORDINANCE(S) FOR SECOND READING

1. Ordinance #32-2008 Creating the Position of Municipal Department Head

Alderman Visioli explained that the ordinance is to create a position of Municipal Department Head. As we all know we have hired an individual and the personnel committee believes that this individual is highly qualified to be part of the "merger team," to merge DPW and DWC and he's looking forward to great things for him.

Alderman Donofrio wanted some clarification on the status of the certifications (Water Licenses) held by the employee hired for this position. Mayor Dodd explained that the new hire does not hold a certification but he's willing to obtain one. Mayor Dodd expressed that the Personnel Committee felt that it wasn't necessary to hold that certification since someone on staff currently has the certification. Alderman Donofrio noted that he would personally feel more at ease if the position incorporated the possession of those two licenses. Alderman Donofrio is prepared to vote in the affirmative for the candidate but he would like some sort of timeline when those licenses would be in his possession. Alderman Visioli expressed that those particular licenses are not a requirement for the managerial position since there's a secondary back-up and an employee is doing that particular function as of now.

Alderwomen Romaine had a question regarding #3 on the resolution list. She wanted to know if the town set limitations on the number of companies the town can have or the number of cabs. Attorney Pennella and Clerk Verga explained the limitations were set on the number of cabs a company can have. Alderman Timpani wanted to know how taxi and limos are identified. Attorney Pennella explained that limos and taxis have different registrations that distinguish the two.

#### REGULAR MEETING MINUTES November 10, 2008

The Regular Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

The meeting was called to order by Mayor Dodd at 7:18pm

#### ROLL CALL

Present: Aldermen Delaney, Poolas, Visioli, Donofrio, Picciallo, Timpani, Romaine and Mayor Dodd

Absent: Alderman Fahy

Also present were Attorney Pennella and Clerk Verga

Clerk Verga stated adequate notice was given to the official newspaper.

Mayor Dodd opened this portion of the meeting to the public for agenda items only, seeing no hands and hearing no voices he then closed this portion of the meeting.

Mayor Dodd's Report – Mayor Dodd noted that they've been holding several meetings to discuss the town's financial position for 2009 and expressed that it doesn't look good; funding has been scarce from the state. In 2008, it was extremely difficult were the town took a 19 point increase and had the ability to reduce it to 11 points but he's not to sure it can be done again. The town will try to come up with some creative financing to ease the burden on the taxpayers.

He's glad to say that an agreement has been reached with FMBA Local 60 and believes it's a win-win for both parties. Mayor Dodd and Alderman Poolas attended a ribbon cutting ceremony for Morristown Federal Credit Union; he commended and congratulated them for coming to Dover. Mayor Dodd congratulated Dover Renaissance for the 17<sup>th</sup> Annual 5K Run.

Mayor Dodd expressed that they have been holding parking committee meetings and they've been looking at ways to generate revenues for 2009. He feels that the parking utility has been neglected in the past and it should be a state of the art utility. Dover is a commuter friendly town and the parking utility should really be looked into. In 2009, the town will implement the Kiosk system in the town's public parking lots, based on a first come-first serve premise. Parking permits will no longer be issued however some locations will (resident parking) require decal permits. The Kiosk is a user friendly system for example, if you're in NY and need to add additional time you can call in and add more time.

The town is also looking into shared services with other communities, currently the court merger is in progress. Mayor Dodd met with Judge Bozonelis and he provided a verbal approval to move forward with the court shared services plan. There are some obstacles that need to be worked out and the next meeting is scheduled for Wednesday which the Mayor hopes to have a signed agreement.

#### ALDERMEN/COMMITTEE REPORTS -

Alderman Fahv – Absent

Alderman Picciallo – Alderman Picciallo attended a Memorial Association meeting to discuss future plans for the parade. Alderman Picciallo and Alderman Poolas provided the seniors at Millpond Towers with a Halloween Party. Alderman Visioli donated the trophies for their costume contest and the food was donated by Attilio's Tavern and Costco. He attended a JJ Rich Senior Housing board meeting. He addressed a speeding complaint on Baker & Fairview. He noted that three trees were taken down on No. Sussex by the cemetery and the stumps will be removed in the near future with the road department. He explained a capital improvement project is in progress between Pequannock and North Sussex Streets. Alderman Picciallo and Alderman Poolas attended the Dover Renaissance 5K Run.

Alderman Poolas – Alderman Poolas received an e-mail from a gentleman that is stationed in the United States Army wanting to know what Dover does for Veteran's Day and how Dover honors the military. Alderman Poolas, Connie Foster, Kay Walker responded to his e-mail and advised him of all the patriotic events that take place throughout the year. The Memorial Association has set-up a display in the foyer honoring Veterans. The Memorial Association will hold a candle light vigil and prayer at Veteran's Path at Hurd Park. Alderman Poolas reminded the public to think about June 6, 2009 because it's the Fire Department 135<sup>th</sup> Anniversary Parade and everyone should get involved. Mayor Dodd commended Alderman Poolas for the Veteran's Display.

Alderman Donofrio - Alderman Donofrio attended the Chronic Disease and Value Based Benefit Design meeting held by

Assemblyman Webber which covered "how to lower health care costs and make employees healthier and more productive." Alderman Donofrio attended the Halloween Festivities sponsored by the Recreation Dept.

**Alderman Timpani** – Alderman Timpani is glad that the elections are over and he's ready to serve the town, again. Alderman Timpani noticed that at the last meeting there was a discussion about a piece of property that was divided among two neighbors and he has a concern about a piece of property at the end of Myrtle Ave. Mayor Dodd asked Alderman Timpani to speak with the Engineering Department for a recommendation and asked the Attorney to look into it.

**Alderman Delaney** – Alderman Delaney attended several shared court meetings and commented that when there's different towns involved it can be difficult because everyone has different ideas on what should be done. He encouraged the board to vote for the Firemen's Agreement. Alderman Delaney noted that there has been previous meetings' regarding the parking utility and the equipment would be a big boost for the town. Alderman Delaney thanked the residents for voting and the people who worked the polls.

Alderman Visioli – No Formal Report

**Alderwomen Romaine** – Alderwoman Romaine commented on the parking utility and noted that she has seen the kiosk system in Nutley and their residents are really happy with the system. She attended a recreation meeting and plans are underway for some enhancements to the 2009 summer program (additional program, extended hours). The participants in the summer program will see some increases in cost. The Recreation Commission met with coaches regarding the rules and regulations and proper protocol to follow if there's an accident or incident. The Dover Board of Education didn't budget for the rental of school buses and janitors so the cost of the trips will increase.

Attorney Pennella Report – Since the last meeting, there has been one motion that was argued with regards to the taxi cab case. Dover has won the second round however during the hearing the plaintiffs raised, for the first time, an argument that was not contained in their complaints but it had been contained in the complaints of Azua, which is an out of town company. There's an allegation, although it's denied, that Dover Livery which is a limo company is operating as a taxi company which is not the case at all. The court has allowed the plaintiff to explore that opportunity and a schedule has been set up. Attorney Pennella is confident that Dover will win this argument.

## AN ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER, COUNTY OF MORRIS AND STATE OF NEW JERSEY AMENDING AND SUPPLEMENTING CHAPTER 72, SALARIES AND COMPENSATION

Be it ORDAINED by the Mayor and Board of Aldermen, Town of Dover, County of Morris, NJ as follows:

A. CHAPTER C. "Salaries and Compensation for Certain Employees" is hereby amended and supplemented by the following:

### CHAPTER C. SALARIES & COMPENSATION FOR CERTAIN EMPLOYEES

- 1. Effective January 1, 2007 as indicated below, salaries, compensation or fees are hereby establishes for the following named officers, employees or positions in the Town of Dover at the rate of or within the salary ranges listed.
- B. All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistencies.
- C. This ordinance shall take effect immediately upon final passage and publication.

#### ORDINANCE(S) FOR SECOND READING

## ORDINANCE NO. 32-2008 AN ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER CREATING THE POSITION OF MUNICIPAL DEPARTMENT HEAD

**BE IT ORDAINED** by the Mayor and Board of Aldermen of the Town of Dover, county of Morris and State of New Jersey as follows:

- Section 1. There is hereby established in the Code of the Town of Dover a new Section 2.23 entitled Municipal Department Head. The position of Municipal Department Head shall be an unclassified title under Civil Service:
  - A. The Municipal Department Head shall be appointed by a majority of the governing body.
  - B. The term of office is at the pleasure of the Mayor and Board of Aldermen.
- C. The Municipal Department Head shall receive as a salary such sums as may be fixed and adopted by the Salary Ordinance of the Town of Dover.
- D. Qualifications of the Municipal Department Head shall be an engineer by training and maintain other certifications as are required to oversee streets, roads, public buildings and grounds, parks, playgrounds and the municipal water system.
- E. The Municipal Department Head shall report to the Administrator and shall be responsible to the Mayor and Board of Aldermen for the proper and efficient administration of the Department overseen by the Municipal Department Head.
- F. The powers and duties of the Municipal Department Head shall include supervision of maintenance and repair of streets and roads; supervision of the maintenance and repair of public buildings and public grounds, including parks and playgrounds; supervision of maintenance and repair of municipal parking lots; supervision of storm water management; provide memorandum and reports to the Administrator and governing body on municipal infrastructure including short term and long range plans for municipal improvement and recommendations on prioritization of municipal improvement and infrastructure projects; supervise and direct all workers dealing with roads, streets, sewer and water systems, repair and maintenance of public buildings, playgrounds and parks, sanitation operations, and traffic signs and signals.
- G. Prepare a budget for the calendar year to the Administrator providing estimates of revenues and expenditures and other supporting data relating to the activities under the authority of the Municipal Department Head.
- H. Attend meetings of the Mayor and Board of Aldermen upon request and meetings of committees of the Mayor and Board of Aldermen upon request.
- I. Keep the Administrator informed as to the conduct of the activities under the control and supervision of the Municipal Department Head on a daily basis and provide such written reports as are requested by the Administrator or by the Mayor and Board of Aldermen.
- J. Review daily any complaints concerning the functions and activities under the supervision of the Municipal Department Head made by any of its residents and maintaining a permanent record thereof, notifying the Administrator and taking such action as is necessary to address those complaints.
  - K. Perform such other duties as may be assigned by the Mayor and Board of Aldermen.
- Section 2. All ordinances or parts of ordinances inconsistent with this within ordinance are hereby repealed to the extent of such inconsistencies.
- Section 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.
  - Section 4. The Ordinance shall take effect in accordance with law.
