Mayor Dodd called the meeting to order at 7:00 pm

All joined in the Pledge of Allegiance to the Flag and prayer was given asking for guidance and strength to do what is right for our town and our citizens.

REGULAR MEETING MINUTES March 9, 2010

The Regular Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

The meeting was called to order by Mayor Dodd at 7:08 pm

ROLL CALL

Present: Aldermen Delaney, Poolas, Visioli, Donofrio, Picciallo, Timpani, Romaine, Blackman and Mayor Dodd

Also present were Administrator Close, Attorney Pennella and Clerk Verga

Clerk Verga stated adequate notice was given to the official newspaper.

Mayor Dodd opened this portion of the meeting to the public for agenda items only. Seeing no hands and hearing no voices this portion of the meeting was closed to the public.

MAYOR'S REPORT – Mayor Dodd noted that the town has been hosting shared service meetings with adjoining municipalities in the attempt to consolidate services to help save taxpayers money. Mayor Dodd explained that the Environmental Protection Agency (EPA) has started the 2nd phase of well #4 clean up on Route 46. He noted that EPA will inject chemicals into the soil to neutralize the contamination. He explained that, hopefully, after the 2nd phase the properties that were condemned would be turned over and placed up for sale which would bring back ratables to the town. Mayor Dodd explained that several ratables have been lost because multi-families homes were condemned and there was the removal of the diner property, car lot and three houses for the expansion of Route 46. Mayor Dodd thanked the Department of Public Works (DPW) for the sign installation at Pequannock St. and Clinton St. to notify the public that the businesses remain open during the bridge construction. He noted that personnel and finance committee meetings continue as we develop the 2010 budget. Mayor Dodd congratulated Administrator Mr. Close for his one year anniversary with the town.

COMMITTEE REPORTS

FINANCE – Alderwoman Romaine explained that the finance committee is still working on the budget and a meeting is scheduled for tomorrow. She noted that the committee hopes to have everything finalized shortly.

PUBLIC WORKS – Alderman Poolas noted that the committee met on February 9th and March 8th and they discussed the water main breaks in town. He was given a tour of the water main map and shown the process on how water mains are closed down. The committee talked about the salt shed being filled and noted that a lot of salt has been used this year. He noted that the Department of Public Works (DPW) is in the process of purchasing new garbage receptacles for JFK Park and suggested recyclable receptacles for bottles and cans as well. He noted a DPW employee has retired and discussion is taking place on whether or not to fill the position. He explained that there are a total of 17 DPW employees of which - 3 run the street sweepers, 2 are custodians, 2 are mechanics and 2 work yard waste which leaves 8 employees to do the other work under DPW. He noted that there was some talk about the merger of the water and street departments. Alderman Poolas noted that DPW would like to see the flea market purchase their own barricades and put them up themselves. He discussed the cost effectiveness of putting paving blocks or stamped concrete on some of the islands that divide the roadways in town, feeling this would eliminate the upkeep of the lawn and believes it would look attractive. Alderman Poolas added that a letter was received in reference to the traffic nightmare on Pequannock Street & Fairview Avenue from Mr. Gilbert. He noted that one way avenues should be looked into. Mr. Close noted that signs are anticipated by Department of Transportation by next week and there has been a request for increased police patrol in those areas.

LIBRARY – Alderman Donofrio noted that next week there will be a library meeting and will provide his report at the next town meeting.

HEALTH – Alderman Delaney noted that January & February sales for garbage stickers brought in \$4,300 and revenues for the first two months were \$18,146 which includes marriage, birth and death certificates. He noted that food establishment inspections are ongoing. He noted that several clinics have been scheduled for the upcoming months and noted that the H1N1 vaccinations are still available, if interested please contact the health department.

PERSONNEL – Alderman Visioli stated the personnel committee meets the 1st Tuesday of every month at 6:00 pm. He thanked the committee and Mr. Close for working together. He noted that there are several matters that need to be resolved and assured the public the committee is working diligently to resolve the matters.

CONSTRUCTION, ZONING, ENGINEERING & CODE ENFORCEMENT – Alderman Timpani provided the board with pictures of the King Field Concession Stand project. He noted that the project is moving along and the contractors are eager to meet their deadline. He provided a breakdown of the summonses issued for sidewalks not being shoveled and stated we really do have compliance throughout town.

ADMINISTRATOR'S REPORT -

Administrator Close reiterated about the various meeting concerning shared services. Alderman Donofrio wanted to know if there are grants specifically for shared services. Administrator Close explained that there isn't a grant specifically for shared services. Various grants are being applied for \$650,000 for the Munson Creek sewer rehabilitation, NJ Transit, and an energy grant to name a few. He stated the board was given a letter from Locust Hill Cemetery requesting the town take over an easement on their property to address drainage problems. He also made the board aware that a letter was sent to Parkeon expressing concerns with the support services with the kiosk system.

ATTORNEY PENNELLA – He asked for the boards support for the two resolutions on the agenda for tax appeals which will resolve the 2008 & 2009 complaints for Dover Garden Apartments I and II. He expressed that he has received about half a dozen tax appeals for 2010 with the filing deadline being April 1st. He noted that the 1st week in April the town should have an idea of the amount of state appeals that have been received. He expressed that there's about 25 county tax board appeals.

PUBLIC PORTION – AGENDA ITEMS ONLY - Mayor Dodd opened the meeting up to the public, seeing no hands and hearing no voices the meeting was closed to the public.

RESOLUTION CONFIRMING THE DETAILS OF THE SALE OF BONDS IN THE AGGREGATE PRINCIPAL AMOUNT OF \$607,500 OF THE TOWN OF DOVER, IN THE COUNTY OF MORRIS, NEW JERSEY, TO THE NEW JERSEY ENVIRONMENTAL INFRASTRUCTURE TRUST PURSUANT TO THE 2010 NEW JERSEY ENVIRONMENTAL INFRASTRUCTURE TRUST FINANCING PROGRAM

WHEREAS, the Town of Dover (the "Town"), in the County of Morris, New Jersey, has determined that there exists a need within the Local Unit to acquire, construct, renovate or install the Project (the "Project") as defined in each of that certain Loan Agreement (the "Trust Loan Agreement") to be entered into by and between the Town and the New Jersey Environmental Infrastructure Trust (the "Trust") and that certain Loan Agreement (the "Fund Loan Agreement") and together with the Trust Loan Agreement, the "Loan Agreements") to be entered into between the Town and the State of New Jersey, acting by and through the New Jersey Department of Environmental Protection (the "Program"); and

WHEREAS, the Town has determined to finance the acquisition, construction, renovation or installation of the Project with the proceeds of a loan to be made by each of the Trust (the "Trust Loan") and the State (the "Fund Loan"), and together with the Trust Loan, the "Loans") pursuant to the Trust Loan Agreement and the Fund Loan Agreement, respectively;

WHEREAS, to evidence the Loans, each of the Trust and the State require the Town to authorize, execute, attest and deliver

the Town's Bonds, Series 2010, to the Trust in an aggregate principal amount not to exceed \$150,000 (the "Trust Loan Bond") and Loan Bonds, Series 2010, to the State in an aggregate principal amount not to exceed \$457,500 (the Fund Loan Bond") and together with the Trust Loan Bond, the "Town Bonds") pursuant to the terms of the Local Bond Law of the State of New Jersey, constituting Chapter 2 of Title 40A of the Revised Statutes of the State of New Jersey (the "Local Bond Law"), other applicable law, the Loan Agreements and the Escrow Agreement dated January 6, 2010 (the "Escrow Agreement") by and among the Trust, the State, the Local Unit and the escrow agent named therein; and

WHEREAS, N.J.S.A. 40A:2-27(a)(2) of the Local Bond Law allows for the sale of the Trust Loan Bond and the Fund Loan Bond to the Trust, without any public offering, and N.J.S.A. 58:11B-9(a) allows for the sale of the Trust Loan Bond to the Trust, without any public offering, all under the terms and conditions set forth herein; and

WHEREAS, in accordance with the terms of the Escrow Agreement, the Trust has sold its bonds to fund the Trust Loan, thereby enabling the Town to confirm the exact aggregate principal amount of and debt service schedule for the Town Bonds.

NOW, THEREFORE, BE IT RESOLVED, BY THE GOVERNING BODY OF THE TOWN AS FOLLOWS:

Section 1. The sale of the Trust Loan Bond to the Fund Loan Bond to the State is hereby confirmed. The Trust Loan Bond shall be released from escrow in accordance with the terms of the Escrow Agreement and thereby issued in accordance with the principal loan amount, interest rates and maturity schedule set forth in **Schedule A** attached hereto and made a part hereof. The Fund Loan Bond shall be released from escrow in accordance with the terms of the Escrow Agreement and thereby issued in accordance with the maturity schedule set forth in **Schedule B** attached hereto and made a part hereof.

Section 2. This resolution shall take effect immediately.

Section 3. Upon the adoption hereof, the Town Clerk shall forward certified copies of this resolution to John G. Hudak, Esq., bond counsel to the Town, and Adam R. Wendell, Esq., McCarter & English, LLP, bond counsel to the Trust.

- 1. The tax court appeals bearing the above referenced docket number is hereby authorized to be settled for the fair market value amount for year 2008 at 2,681,600.00 and for 2009 at 6,621,400.00. The fair market value for the year 2010 shall be 6,366,000.00
- 2. The settlement shall be paid by tax credit to future tax bills and not by refund.

- 3. The taxpayer must waive interest on the overpaid amounts.
- 4. The Municipal Attorney is hereby authorized to execute a Stipulation of Settlement upon the terms set forth above.

Alderwoman Blackman has moved the foregoing resolution be adopted and duly seconded by Alderman Timpani and passed by the following roll call vote.

PUBLIC COMMENTS – Three Minutes per Person

EDWARD CORREA – 88A E. Blackwell Street – Mr. Correa wanted to know when the town changed the law for the enforcement of Sunday parking. Mayor Dodd explained that the law was in effect, but not enforced because the town didn't have staggering manpower. He wanted to know if it was a monetary need to balance the budget. Mayor Dodd expressed that it was never looked at as a way of balancing the budget but looked at as a way of getting compliance. Mayor Dodd expressed that it's the town obligation to enforce the laws that are in place. Mayor Dodd noted that the town now has a parking committee which recommended staggering the shift for better coverage and enforcement of the law. Mr. Correa commented that the law was written but never enforced on Sundays. Mayor Dodd clarified that he can't say that the law was never enforced but now they have staggering shifts which allows for enforcement. Mr. Correa wanted to know what the town was doing to encourage participation in the 2010 Census. Mayor Dodd stated a meeting was held with census representatives along with Congressman Frelinghuysen's staff. Literature promoting the census is posted in town hall; also the census van and reps had an open house at town hall, just to name a few things the town is doing to promote the census. Mr. Ulysses Isa has partnered with the town assist with the promotion of the census. Clerk Verga stated the town has worked with census personnel in making sure all addresses on record are correct.

DEBBIE MANTINI – 305 E. McFarlan Street – Ms. Mantini expressed that the reason people are upset is because historically tickets were never issued on Sundays. She noted that people just need to be educated on the laws. Administrator Close stated warnings were issued at first.

EDWARD CORREA – 88A E. Blackwell Street – Mr. Correa expressed that parishioners, restaurant owners, residents and commuters are upset. He suggested that the ordinance be reviewed to exclude Sunday enforcement. Mayor Dodd noted that it is a compliance issue and the town has always taken a position to have users pay. He noted that the municipal lots require maintenance (milling, paving, line painting) and feels that it should be paid by the commuters and not by the taxpayers of Dover. Mayor Dodd provided an example that Lot D will require maintenance which will cost half a million dollars and it should not be the taxpayers' responsibility to pay the bill. Mr. Correa noted that he is a resident of Park Plaza (Blackwell St.) and has to get up at 7:00am on Sunday to move his car because there's two hour enforcement. Mayor Dodd expressed that the town made arrangements for residents to purchase a parking permit for the River Street lot. Mr. Correa was not aware of this arrangement.

Seeing no hands and hearing no voices, Mayor Dodd closed this portion of the meeting to the public and asked for a motion to adjourn.
