## REGULAR MEETING MINUTES

June 9, 2015

The Regular Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

The meeting was called to order by Mayor Dodd at 7:08 pm

### ROLL CALL

Present: Aldermen Picciallo, Romaine, Blackman, Rutan, Noriega, MacDonald, Toth and Mayor Dodd

Absent: Alderman Visioli

Also present were Municipal Clerk Margaret Verga, Administrator Donald Travisano and Attorney Downs

Municipal Clerk Verga stated adequate notice was given to the official newspaper.

Mayor Dodd opened the meeting to the public on any agenda items.

**FRANCISCO DE JESUS** – 53 Mountain Ave, Dover - He wanted to know why the Waterworks site cannot be used for the event (Colombian Festival). Mayor Dodd commented that the last time the event was held at Waterworks Park, there were a lot of complaints due to it being located in a residential area. The board felt it was best for the event to be held in the parking lot of Crescent Field. Mr. Travisano commented that there were also concerns from the Fire Department due to the large number of attendees and the condition of the bridge which is the only entrance and exit to the park. Mayor Dodd supports the Colombian Festival and would like them to be successful but noted that there are issues associated with event because it has become so large and those issues needed to be addressed.

**EMILIANO LEMOS** – He wanted to know if the complaints that were made regarding the Colombian Festival are still on record and asked if copies could be provided. Mayor Dodd noted that an Open Public Records Act (OPRA) request can be completed for any public records. Clerk Verga noted that complaints from 10 years would have been destroyed.

(The Colombian Festival was held at the Waterworks Park approximately 10 years ago. The last several years the festivals were held at Crescent Field Park.)

Mayor Dodd explained that complaints were made verbally and written. The complaints that were received were due to garbage, parking, noise, etc. He noted that the location for this year's event is the parking lot which is located near the train station and in a commercial zone. This location will help alleviate many of the complaints. Alderwoman Romaine commented on the complaint that she received.

Mr. Travisano explained that the application that was made by Club Colombia did not request the Waterworks Park and clarified that the fire department would not have allowed it due to public safety issues. He also mentioned that Waterworks Park has no parking available.

**DOMINIC TIMPANI** – 2 Elm Street, Dover – He wanted to know why the fire department would not allow the festival to host the event at Waterworks Park. Mr. Travisano noted that in previous discussions, the fire department expressed that there's an access problem, there's only one entrance and exit to the park and due to the large number of attendees it makes it a public safety issue. Mr. Timpani wanted to know if there will be concerns with the town's senior citizens picnic since there's concern with the Colombian Festival using the location at Waterworks Park. It was explained that the senior citizen picnic has approximately 300 senior citizens versus 10,000 festival attendees. It was also noted that senior citizens car pool and use Dial-a-Ride transportation which make parking easier to manage.

Alderman MacDonald asked the public to specify the reasons the Colombian Festival should not be held in the large parking lot by Crescent Field. It was noted that 8,000 to 10,000 people attend the festival.

Mr. Timpani noted that he believes the festival should be held at the Waterworks Park because picnic tables and grills are available. He noted that Waterworks Park is more secluded.

Mr. Travisano reiterated that the application was never made for the Waterworks Park; the request was made for Crescent Field.

Alderwoman Romaine asked why individuals other than the Colombian Festival committee have concerns with the location. Mr. Hernando Mancera, President of Club Colombia noted that the location at the parking lot is not an issue with his committee.

**ORDINANCE FOR INTRODUCTION**

**ORDINANCE NO. 10-2015**

**ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER,  
COUNTY OF MORRIS, STATE OF NEW JERSEY REGULATING GARAGE SALES**

**BE IT ORDAINED** by the Mayor and Board of Aldermen of the Town of Dover as follows:

**SECTION 1: DEFINITIONS.**

As used in this section:

*Garage sales* shall mean and include all sales entitled "**garage sale**," "**lawn sale**," "**attic sale**," "**rummage sale**," or "**flea market sale**," or any similar casual **sale** of tangible personal property which is advertised by any means whereby the public at large is or can be made aware of this **sale**.

*Goods* shall mean and include any goods, merchandise or other property capable of being the object of a **sale** regulated hereunder.

*Household* shall mean any single family or multi-family residential dwelling, individual apartment unit, individual cooperative unit or individual condominium unit.

**SECTION 2: LICENSE REQUIRED; FEE.**

It shall be unlawful for any person to conduct a **garage sale** in the Town without first filing with the Town Clerk the information hereinafter specified and obtaining from the Town Clerk or his or her designee, a license to do so, to be known as a "**Garage Sale License**."

The fee for such license shall be fixed at five (\$5.00) dollars.

**SECTION 3: LICENSE REQUIRED; DISPLAY.**

- a. A license shall be issued to any household only three times during the twelve (12) month period and shall specify the days of the **sale**. No license shall be issued for more than three (3) consecutive calendar days.
- b. In the event that inclement weather causes one (1) or more days of a scheduled **sale** to be canceled, the holder of the license shall be entitled to hold the **sale** the following week, on the same day of the week as originally scheduled, upon first presenting the license to the Town Clerk, who shall make the necessary date changes thereon.
- c. Each license issued under this section must be prominently displayed on the premises upon which the **garage sale** is conducted throughout the entire period of the licensed **sale**.

**SECTION 4: APPLICATION FOR LICENSE.**

No **Garage Sale License** shall be issued unless a written application is first filed with the Town Clerk or his or her designee containing the following information:

- a. Name of person, firm, group, corporation, association, or organization conducting the **sale**.
- b. Name of the owner of the property on which the **sale** is to be conducted, and consent of owner if applicant is other than owner.
- c. Location at which the **sale** is to be conducted.
- d. Number of days of the **sale**.
- e. Date, nature of any past **sale**
- f. Relationship or connection applicant may have had with any other person conducting a **sale** and the date or dates of such **sale**.
- g. Whether or not applicant has been issued any other vendor's license by any local, State or Federal agency.
- h. A certification by the person signing that the information therein given is full and true and known to be so.

**SECTION 5: HOURS OF SALE.**

All **garage sales** shall be conducted between the hours of 9:00 a.m. and 6:00 p.m. only.

**SECTION 6: SIGNS.**

Signs shall not be posted more than three (3) days prior to the **sale** and placement of signs anywhere in town must conform with all applicable laws, including but not limited to the Code of the Town of Dover.

Signs shall be removed within twenty-four (24) hours after the completion of the **sale**. If signs are not removed within twenty-four (24) hours of the completion of the sale, there shall be imposed a fine of \$5.00 per day for each day or part thereof that that the sign remains.

**SECTION 7: EXCEPTIONS.**

The provisions of this section shall not apply to or affect the following persons or sales:

- a. Persons selling goods pursuant to an order or process of a court of competent jurisdiction.
- b. Persons acting in accordance with their powers and duties as public officials.
- c. Any person selling or advertising for **sale** an item or items of personal property which are specifically named or described in the advertisement and which separate items do not exceed five (5) in number.
- d. Any **sale** conducted by any merchant or mercantile or other business establishment from or at a place of business wherein the **sale** would be permitted by the Zoning Regulations of the Town or under the protection of the nonconforming use section thereof or any other **sale** conducted by a manufacturer, dealer

or vendor who would conduct the **sale** from properly zoned premises and not otherwise prohibited in this revision.

**SECTION 8: CONDUCT OF SALE.**

The person to whom such license is issued and the owner or tenant of the premises on which the **sale** or activity is conducted shall be jointly and severally responsible for the maintenance of good order and decorum on the premises during all hours of the **sale** or activity. No person shall permit any loud or boisterous conduct on the premises nor permit vehicles to impede the passage of traffic on any road or streets in the area of the premises. All persons shall obey the reasonable orders of any member of the Police or Fire Departments in order to maintain the public health, safety and welfare

**SECTION 9: ENFORCEMENT.**

This section shall be enforced by the Police Department, Code Enforcement Department and the License Inspector. It shall be the duty of the Police Department, Code Enforcement Department and the License Inspector to investigate any violations of this section coming to their attention, whether by complaint or arising from their personal knowledge, and if a violation is found to exist, they shall issue a summons and/or prosecute a complaint before the local Municipal Court pursuant to the provisions of this section.

**SECTION 10: PENALTY.**

Any person conducting any **sale** or similar activity without being properly licensed therefore or who shall violate any of the other terms and regulations of this section shall, upon conviction, be fined not less than twenty-five (\$25.00) dollars nor more than one hundred (\$100.00) dollars or be imprisoned for a period not to exceed ten (10) days for each violation. Each day that the **sale** shall continue without being duly licensed shall be considered a separate violation.

**SECTION 11:**

All ordinances or parts of ordinances inconsistent with this within ordinance are hereby repealed to the extent of such inconsistencies.

**SECTION 12:**

If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

**SECTION 13:**

The Ordinance shall take effect in accordance with law.

**STATE OF NEW JERSEY AMENDING CHAPTER §57-24 ARTICLE V OF THE CODE OF THE TOWN OF**  
**DOVER ENTITLED “ORGANIZATION OF THE POLICE DEPARTMENT” IN ITS ENTIRETY.**

**BE IT ORDAINED** by the Mayor and Board of Aldermen of the Town of Dover, County of Morris and State of New Jersey that Chapter 57-24 of the Code of the Town of Dover be amended in its entirety to read as follows:

**SECTION 1. Table of Organization**

Police Department. In addition to the Public Safety Director, there shall be:

Chief	1
Lieutenants	3
Sergeants	5
Sergeants assigned detective	0
Police officers assigned detective	2
Police officers	23
Total of police personnel	34

**SECTION 2.**

All ordinances or parts of ordinances inconsistent with the provisions of this ordinance be and the same are hereby repealed.

**SECTION 3.**

If any portion or clause of this ordinance is declared invalid for any reason whatsoever, same shall not affect the validity or constitutionality of any other part or portion of this ordinance.

SECTION 2. All ordinances or parts of ordinances inconsistent with this within ordinance are hereby repealed to the extent of such inconsistencies.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. The Ordinance shall take effect in accordance with law.
