



**TOWN OF DOVER**  
**MAYOR AND BOARD OF ALDERMEN**  
**CAUCUS MEETING MINUTES**  
**June 1, 2010 7:00 PM**

The Caucus Meeting of the Mayor and Board of Aldermen was held in council chambers, 37 N. Sussex Street, Dover, New Jersey.

Mayor Dodd called the meeting to order at 7:00 pm

All joined in the Pledge of Allegiance to the Flag and prayer was given asking for guidance and strength to do what is right for our town and our citizens.

**ROLL CALL:**

Clerk Verga stated adequate notice was given to the official newspaper.

**MUNICIPAL BUDGET PRESENTATION**

Mayor Dodd commented this year has been a very difficult year and they were faced with some very difficult decisions. He expressed that some areas had to be cut but the biggest challenge is cutting areas without affecting the services to the residents. Mayor Dodd noted that the Administrator and Chief Financial Officer (CFO) have put in countless hours into the budget which he is proud to present to the public. Mayor Dodd explained that there were some areas he wished could've gone better and noted that some of the difficulties that we faced will have long ranged impacts which they tried to minimize as much as possible. He's proud that they were able to accomplish the task and explained that the tax impact on a home assessed at \$290,000(town average) will show an increase of \$11.97 a month. Mayor Dodd asked Alderwoman Romaine as Chairwoman to make additional comments.

Alderwoman Romaine noted that they had numerous and countless meetings to put the budget together. She thanked the finance committee which consists of Alderman Picciallo, Alderman Visioli, (herself) and CFO Kelly Toohey and Business Administrator Close. She explained that the school board was able to maintain a flat rate with no increase and noted that taxpayers will only see it on the county and municipal levels. She noted that the average home that is currently assessed at \$290,000 is looking at \$144.00 annual increase which breaks down to \$11.97 a month. She noted that the total budget is down \$225,000 from last year and that takes into consideration the revenue that has been lost, as well as the increase in some of the fixed costs, and the pension fund cost. She noted that Dover is tax levy compliant so they meet all the criteria that the State puts on Dover for putting the budget together. Alderwoman Romaine explained that they where in the negative before starting 2010 because of revenue that was removed from the state as well as the revaluations which put Dover in a negative position from the actually tax collection standpoint. She noted that the revenue from the reassessment was down approximately a half a million dollars. She noted that before they even started they had to overcome about a \$750,000 deficit just to go forward with the increased cost. She expressed that she's very happy with the budget.

Mr. Close commented that the budget couldn't have been put together without the departments, Kelly Toohey and noted that it really was a team work approach. He expressed that no one wants to see an increase but noted that it is an increase that was necessary.

Mr. Dave Evans (Nisivoccia & Company) noted that his company works with about seventy (70) municipalities and doesn't know any that are not struggling with the of loss of state aid, increased pension and insurance costs. He noted that there would not have been a local tax rate increase had the state not cut the state aid and had not increased the pension cost. He believes that Town of Dover is doing an admirable job with the tools that they were given and with the loss of tools, like state aid (\$300,000), increase in pension cost (\$400,000) and increases in insurance which are things that the town has very little control over. Mr. Evans believes the town did an excellent job in approaching the problems and minimizing the impact it will have on the level of services. He noted that the budget also contemplates an increase in the water and sewer rates. Mr. Evans explained that the board will take three actions on the budget which include; resolution of self-examination of the budget, introduction of cost of living adjustment ordinance and the formal introduction of the 2010 budget.

Mayor Dodd opened the meeting to the board for any questions on the municipal budget presentation.

Alderman Picciallo wanted to know how Mr. Evans arrived at the overall number for additional sewer rents (sheet 10). Mr. Evans noted that it's an overall increase of 10% in dollars of what was collected in 2009. Alderman Picciallo wanted to know if the 10% is the increase or new construction. Mr. Evans noted that the increase will end up netting 10% increase in revenue.

Alderman Picciallo noted that the number went down from 2009 to 2010. Mr. Evans clarified that it will go up and down because of the water consumption. Alderwoman Romaine mentioned that they are estimating the 1.5 million, we are looking at 1,525,000.00 it can up or down based on the actual consumption because residents pay for what they use, we don't have a flat rate. Mr. Evans noted that the rate is not based on equivalent dwelling units (EDU) and believes it's the fairest way to bill for sewers. Alderwoman Romaine commented that surrounding municipalities have a quarterly flat rate for sewers. Mr. Evans noted that many municipalities have flat rates but its unfortunate when you bill on the bases of Equivalent Dwelling Units (EDU) and you have access to water consumption data. Mr. Evans mentioned, in his opinion, that EDU is not the fairest way at all and believes that water consumption (users pay) is the fairest way to do it and it's been that way for a number of years (15-20 years). Alderman Picciallo wanted an explanation about the loss in tax appeal revenue. Mr. Evans explained that the town has set aside \$120,000 for tax appeal refunds and he will meet with Kelly after June 30<sup>th</sup> to get an idea of their status. Mr. Evans noted that if the number is going to be significant then he'll recommend a Tax Appeal Refunding Ordinance which takes all of the settled tax appeals and requires the state's authorization for a payback period. The payback period is usually 5-7 years so there wouldn't be a negative impact all in one year instead it will be spread it out. Mayor Dodd commented that the reason for a high number of tax appeals is because the town went through a revaluation process which is mandated by the state every 10 years. Mayor Dodd noted that Dover just completed their revaluation process which generally results in a high rate of tax appeals. Alderman Picciallo mentioned that at the budget meetings, Mr. Close wanted to keep the number under a million dollars however the number is at a million-five. Mr. Close commented that it's a proposed number and the actually number comes down to what the board decides to do. Mr. Evans noted that he doesn't want to belittle a section of the budget but noted that if there's one section of the budget that doesn't obligate you to anything it's the Capital Budget. Mr. Evans would rather see a town put more stuff in the capital budget, kind of a wish list so that there is less than what they have to do if they decide to do any of the improvements. Mayor Dodd noted that one of the things to understand is how the capital budget works, he has been very adamant about not allowing things to deteriorate to the point where it becomes so costly that the town can not afford to repair them. Mayor Dodd noted that the town has an obligation to the taxpayers/residents to do street improvements and road improvements and believes that certain things in the capital are paramount and need to stay. Alderwoman Romaine noted that the actual debt is 1.2 million versus the 1.5 million we receive in grants.

Mayor Dodd commented that many personnel positions have not been filled as they become vacant which has been very difficult to provide the same level of service to the residents. Mr. Close reiterated Mayor Dodd's comments.

### **SELF EXAMINATION OF BUDGET RESOLUTION**

**WHEREAS**, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and

**WHEREAS**, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997; and

**WHEREAS**, pursuant to N.J.A.C. 5:30-7.2 through 7.5 the Town of Dover has been declared eligible to participate in the program by the Division of Local Government Services, and the Chief Financial Office has determined that the local government meets the necessary conditions to participate in the program for the 2010 budget year.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Board of Aldermen, Town of Dover, that in accordance with N.J.S.C. 5:30-7.6a & 7.6b and based upon the Chief Financial Officer's certification, the governing body has found the budget has met the following requirements:

1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:
  - a. Payment of interest and debt redemption charges
  - b. Deferred charges and statutory expenditures
  - c. Cash deficit of preceding year
  - d. Reserve for uncollected taxes
  - e. Other reserves and non-disbursement items
  - f. Any inclusions of amounts required for school purposes
2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at N.J.S.A. 40A:4-45.3 et seq., are fully met (complies with CAP law).
3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
4. That pursuant to the Local Budget Law:
  - a. All estimates of revenue are reasonable, accurate, and correctly stated

- b. Items of appropriation are properly set forth
- c. In itemization, form, arrangement and content, the budget will permit the exercise of the comptroller function within the municipality.

5. The budget and associated amendments have been introduced and publicly advertised in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.

6. That all other applicable statutory requirements have been fulfilled.

**BE IT FURTHER RESOLVED** that a copy of this resolution will be forwarded to the Director of the Division of Local Government Services upon adoption.

**ORDINANCE NO. 07-2010**

**CALENDAR YEAR 2010 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET**  
**APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK N.J.S.A. 40a:4-45.14)**

**WHEREAS**, the Local Government Cap Law, N.J.S.40A"4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 0% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

**WHEREAS**, N.J.S.A. 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

**WHEREAS**, the Mayor and Board of Aldermen of the Town of Dover in the County of Morris finds it advisable and necessary to increase its CY 2010 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and

**WHEREAS**, the Mayor and Board of Aldermen hereby determines that a 3.5% increase in the budget for said year, amounting to \$475,895 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and

**WHEREAS**, the Mayor and Board of Aldermen hereby determine that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

**NOW, THEREFORE, BE IT ORDAINED**, by the Mayor and Board of Aldermen of the Town of Dover, in the County of Morris, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2010 budget year, the final appropriations of the Town of Dover shall, in accordance with this ordinance and N.J.S.A. 40A:4-45.14, be increased by 3.5%, amounting to \$475,895 and that the CY 2010 municipal budget for the Town of Dover be approved and adopted in accordance with this ordinance; and,

**BE IT FURTHER ORDAINED**, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.
