Mayor Dodd attended the Mayor's Institute at Princeton University for three days on community design. Everything they spoke about we have in our plan. Hats off to our professionals for being on the cutting edge of development.

Dave Roberts spoke about the Bassett Highway Redevelopment Plan that includes a portion of the area in need of rehabilitation. Economic development committee takes that area and requires three major components: formalize that plan and gives a blueprint or outline to which the development community can respond.

Competitive process RFP developers would have to submit a concept plan for 5 acres or more We have our professionals who developed the plan here tonight, including Dave Roberts, Schoor DePalma- Joe Marizitti, Esq., Legal Council and our own engineer, Mike Hantson.

### ***SMALL CITIES COMMUNITY DEVELOPMENT BLOCK GRANT PUBLIC HEARING AND RESOLUTIONS***

Carol Hertwick, of the Housing and Community Development Services, is a consultant who is preparing the Small Cities Program Applications for the Town of Dover. Ms. Hertwick described for the Board and public the projects, for which the two applications to be submitted September 1, 2006 are for and also the status of the open projects. The town has been awarded money from this program 23 times in the past.

The Housing Rehabilitation Program and stated the town is applying for a grant of \$200,000 with a 10% match so the program is \$220,000. The program provides financial assistance for low to moderate income households to make post compliance repairs to homes. We assist ten homes per year. It also provides the town with an opportunity to address the council on affordable housing obligations for indigent needs and the numbers go towards the quotient the state has identified as the town's obligation. In all cases the monies that are paid to the homeowner for repairs are paid back when the property is sold in that has resulted in a revolving account. Every year monies come back and then loaned back out again to other homeowners or can be used towards the towns 10% match.

The second application is for infrastructure repairs. The project location is on Searing Street from Mt. Hope Ave. to Route 46 and extends on the other side of Route 46 to Nelson Street. This project will correct substandard conditions, which includes curbing, paving, storm-inlets and other related improvements. The town is applying for \$400,000 from the Department of community Affairs and must provide a 10% match or \$40,000, so the total grant would be \$440,000. The project would provide for engineering, administration and construction. This project addresses the needs of a moderate income area and the infrastructure needs proposed would be totally corrected.

The third public hearing issue deals with the status of the two open projects. One is the current \$200,000 housing rehabilitation project. There are 10 ten properties that will be assisted this year. That project was awarded in December and will be completed in October.

The other open project is Phase II, Myrtle Avenue, which is for \$271,600 for infrastructure improvements, including curbing, drainage, sidewalk, curbs and paving. The project is about to begin and will completed no later than October also. It will complete all the improvements needed along Myrtle Ave.

Alderman Fahy asked how many homeowners we help and is there currently a backlog of applicants. Ms. Hertwick stated there is a wait list but not significant at this time.

Mayor Dodd stated it is a very good program and it helps our residents comply with the town codes. Ms. Herwick stated most improvements are for roofing, plumbing and heating, and that the type of work being done raises the value of the property.

Connie Sibona-Foster, 90 Penn Ave. asked what the income guidelines are for the program. Ms.

Hertwick stated they are set by the Department of Community affairs and are related to the number of persons in the household. Currently, they are: 1- person \$41,000, 2 - person \$47,000, 3-person \$53,000 and it goes up every year.

Sandra Scarneo, 66 First Street asked how many years the program has been in Dover and who keeps track when a property is sold. Ms. Hertwick answered Dover has had the program for 23 years and when a mortgage is taken out there is a lien put against the property. When a property is sold, a title search is done and it shows up as a lien. Ms. Hertwick stated the town's account is in excess of around \$100,000 that represents that houses were sold and monies have gone back into account.

Mayor Dodd asked if there was anybody else from the public wishing to be heard. Seeing no hands or hearing no voices, he closed this part of the meeting to the public.

#### **CALL TO ORDER**

Mayor Dodd called the meeting to order at 7:39 pm

#### **ROLL CALL**

#### **SUNSHINE LAW STATEMENT**

In accordance with the provisions set forth in the Open Public Meeting Law, notification of this meeting has been sent to all officially designated Town newspapers and notice is posted in the Town Hall.

#### **PUBLIC COMMENTS**

This portion of the meeting was opened to the Public by Mayor Dodd for agenda items only. No one from public was heard. This portion of the meeting was closed to the public.

#### **ADMINISTRATOR'S REPORT**

Town has taken possession of the New Dial A Ride bus. Met with business owners in down town area relating to loading zone concerns, an analysis and plan should be in place by next meeting. DPW efficiency study was reported on aligning functions.

#### **MAYOR'S REPORT**

Second public input meeting on Bassett Highway project was held. First Town newsletter is at the printers. It was sponsored by local businesses at no cost to the tax payers,. A newer version of the sidewalk sweeper was evaluated. Alderman Visioli was appointed as liaison to the Water Commission. As there is an opening, the mayor recommended appointment of Antonio Acosta to the Board of Adjustment. The mayor requested that a letter be sent to businesses in the down town area to see if in fact loading zones are necessary and/or required. We may want to revert back to parking spots, whatever accommodates the businesses in the area. At previous meeting a resolution was adopted for fire training, some contrary information may have been received. The resolution has not been forwarded to Department of Community Affairs. Mayor requests that Fire Commissioner, along with Committee, meet with all aspects of Fire Dept. to get as much information as they can and report back to the board. In the future, anyone who would like to bring a resolution to the board, research must be done prior to the adoption of the resolution with all parties involved.

#### **ALDERMEN/COMMITTEE REPORTS**

##### **Alderman Newman:**

Streets and Road doing job required of them. Requests Police Department looks into prohibiting left hand turns going south Dickerson and Prospect Streets. Mayor also asked Administrator to look into a request from a few years ago prohibiting right turns on red in the down town area.

##### **Alderman Visioli:**

CARES program was looked in to with the possibility of bringing it into our senior facilities. Alderman Visioli reported for Alderman Delaney that we are participating in the Click it or Ticket program. Fire Department Truck 5 is back in service.

The Dover Board of Education has received many grants from corporations this year. Alderman Ryan attended the Dover Historic Preservation Committee Meeting and reported on same. He also reported that the New York Skyliners received permission from Board of Education to use the high school parking lot to practice.

### **Alderman Burbridge:**

The Library Board needs another citizen participant. Shade Tree Commission meeting was attended. They are hoping to get the Shade Conservation Grant in by June 1. Again Dover NJ was named a Tree City USA for 2005. Dover has received this recognition for over 26 years. Placement of bike racks (2) will be at the train station and (2) near Crescent Field. Alderman Burbridge reported that the Town Engineers is getting quotes on racks of the more historical nature.

### **Alderman Poolas:**

Regarding Board of Health issues, Alderman Poolas reports that the bulk stickers are only sold during the day when Town Hall is open. We should go back to selling them on Saturday's at the town garage as a convenience to our residents. Discussions were held with residents at Mill Pond Towers senior citizens building addressing their questions and concerns. The residents asked for more police presence behind Krauzers. Umbrellas and picnic tables have been donated. They would like an attorney to address wills, etc. The fishing derby is June 3.

BOND ORDINANCE PROVIDING FOR VARIOUS IMPROVEMENTS AND APPROPRIATING THE SUM OF \$1,475,598 THEREFOR, AND AUTHORIZING THE ISSUANCE OF \$1,363,817 OF BONDS OR NOTES FOR

THE PURPOSES SET FORTH HEREIN AUTHORIZED TO BE UNDERTAKEN IN AND BY THE TOWN OF DOVER, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF DOVER, IN THE COUNTY OF MORRIS, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. The improvements and purposes described in Section 3 of this bond ordinance are hereby authorized as general improvements to be made or acquired by the Town of Dover, County of Morris, New Jersey (hereinafter referred to as the "Town"). For said improvements or purposes stated in Section 3 of this bond ordinance, there is hereby appropriated \$1,475,598, said sum being inclusive of all appropriations heretofore made therefore and including the sum of \$111,781 as the aggregate down payment from the Capital Improvement Fund or other funds of the Town which sum is now available by virtue of a provision in the currently adopted budget or a previously adopted budget of the Town and is currently available for down payment or capital improvement purpose, as required by the Local Bond Law of New Jersey N.J.S.A. 40A:2-1 et seq.(the "Local Bond Law").

Section 2. For the financing of said improvements or purposes and to meet the part of said \$1,475,598 appropriation not otherwise provided for hereunder, negotiable bonds of the Town are hereby authorized to be issued in a principal amount not to exceed \$1,363,817 pursuant to the Local Bond Law. In anticipation of the issuance of said bonds, negotiable notes of the Town in a principal amount not exceeding \$1,363,817 are hereby authorized to be issued pursuant to and within the limitations prescribed by said Law. In the event that bonds are issued pursuant to this ordinance, the aggregate amount of notes hereby authorized to be issued shall be reduced by an amount equal to the principal amount of the bonds so issued. If the aggregate amount of outstanding bonds and notes issued pursuant to this ordinance shall at any time exceed \$1,363,817, the moneys raised by the issuance of said bonds shall, to not less than the amount of such excess, be applied to the payment of such notes then outstanding, at maturity. Each bond anticipation note issued pursuant to this ordinance shall be dated or about the date of its issuance and shall be payable not more than one (1) year from its date, shall bear interest at a rate per annum as may be hereafter determined within the limitations prescribed by law and may be renewed from time to time pursuant to and within the limitations prescribed by the Local Bond Law. Each of said notes shall be signed and shall be under the seal of said Town and attested as permitted by law. The appropriate Town officers are hereby authorized to execute said notes and to issue said notes in such form as they may adopt in conformity with law. The power to determine all matters in connection with this ordinance and also the power to sell said notes is hereby delegated to the Chief Financial Officer of the Town (the "Financial Officer"), who is hereby authorized to sell said notes either at one time or from time to time in the manner provided by law, and the Financial Officer's signature upon the notes shall be conclusive evidence as to all such determinations. The Financial Officer is authorized and directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of notes pursuant to this ordinance is made, such report to include the principal amount, description, interest rate and maturity of the notes sold, the price obtained and the name of the purchaser.

Section 3. The improvements hereby authorized and the purposes for the financing for which said obligations are to be issued are:
