AN ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF DOVER AMENDING

## AND SUPPLEMENTING ARTICLE XXVII OF THE REVISED GENERAL CODE OF THE TOWN OF DOVER ENTITLED "PARKING" HANDICAPPED PARKING "SPACES" BY REPEALING HANDICAPPED PARKING SPACES AT VARIOUS LOCATIONS

BE IT ORDAINED by the Mayor and Board of Aldermen of the Town of Dover, County of Morris, and State of New Jersey as follows:

SECTION 1. The following locations were designated as Handicapped parking spaces by Ordinances as listed below are hereby repealed:

Ord. No. 03-2010 – 68 Prospect St.

## ORDINANCE NO. 23-2017 <u>AN ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN</u> <u>OF DOVER, COUNTY OF MORRIS, STATE OF NEW JERSEY AMENDING</u> <u>CHAPTER 57 OF THE CODE OF THE TOWN OF DOVER ENTITLED "POLICE</u> <u>DEPARTMENT" BY ADDING ARTICLE VI, CHAPTER 57, SECTION 25</u> <u>SUBTITLED "POLICE CHAPLAIN."</u>

**BE IT ORDAINED** by the Mayor and Board of Aldermen of the Town of Dover, County of Morris and State of New Jersey, as follows:

**WHEREAS**, N.J.S.A. 48:14-141 authorizes the Mayor and Board of Aldermen of the Town of Dover to create the position of Chaplain within the Police Department; and

**WHEREAS**, Police Chaplains serve an integral role in providing comfort to members of the Police Department, as well as to the public and aid in community policing; and

**WHEREAS**, the Mayor and Board of Aldermen find that providing for the appointment of one or more Chaplains to the Police Department and Fire Department to be in the best interests of the Town of Dover; now, therefore,

**BE IT ORDAINED** by the Mayor and Board of Aldermen of the Town of Dover as follows:

## SECTION 1. CHAPTER AND SECTION ESTABLISHED

ARTICLE VI, CHAPTER 57-25 POLICE CHAPLAIN

## <u>SECTION 2</u>. POSITION OF POLICE CHAPLAIN ESTABLISHED

Pursuant to N.J.S.A. 40A:14-141, the position of Police Chaplain for the Town of Dover is hereby created. The position of Police Chaplain shall be a volunteer position under the supervision of the Public Safety Director and Chief Law Enforcement Officer of the Dover Police Department.

## SECTION 3. APPOINTMENT

Police Chaplains shall be appointed by the Mayor with advice and consent of the governing body.

## SECTION 4. QUALIFICATIONS

A. All applicants for the position of Police Chaplain shall be reviewed by the Public Safety Director and Chief Law Enforcement Officer to determine that his/her qualifications are in accordance with this Ordinance and shall make recommendations to the Mayor and Board of Aldermen.

B. Any person appointed as Police Chaplain shall be an ordained clergyman in good standing in the religious body from which he/she is selected. The Chaplain shall be a certified Police Chaplain credentialed in accordance with the rules and regulations of the Dover Police Department and shall be qualified in accordance with N.J.S.A. 40A:14-141.

#### SECTION 5. NUMBER OF POLICE CHAPLAINS; TERM OF OFFICE

There may be up to four (4) Police Chaplains appointed at any given time. A person appointed as Police Chaplain shall serve from the date of appointment and shall continue to serve in that capacity until he/she is terminated, resigns or retires from that position.

#### <u>SECTION 6</u>. DUTIES

The duties of the Police Chaplain shall include, but not be limited to, assisting the Dover Police Department in any duties that may be assigned by the Public Safety Director and Chief Law Enforcement Officer that pertain to the Police Chaplaincy, including, but not limited to community policing initiatives and death notifications.

#### SECTION 7. RANK AND SALARY

Any person appointed as Police Chaplain shall serve in that capacity without Rank or Salary. The position will be a volunteer position.

#### SECTION 8.

All ordinances or parts of ordinances inconsistent with this within ordinance are hereby repealed to the extent of such inconsistencies.

#### SECTION 9.

If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and <sup>i</sup>ndependent provision, and such holding shall not affect the validity of the remaining portions hereof.

#### SECTION 10.

The Ordinance shall take effect in accordance with law.
