**RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE  
TOWN OF DOVER APPOINTING AN ACTING MUNICIPAL CLERK**

**WHEREAS**, pursuant to N.J.S.A. 40A:9-133, the Town of Dover (the “Town”) is required to employ a Registered Municipal Clerk (the “Clerk”); and

**WHEREAS**, on December 13, 2019, a vacancy occurred in the Office of the Municipal Clerk caused by the departure of the Township’s Registered Municipal Clerk; and

**WHEREAS**, pursuant to N.J.S.A. 40A:9-133, the Town may appoint an Acting Municipal Clerk for a period not to exceed one (1) year and commencing on the date of the vacancy; and

**WHEREAS**, the person appointed may be appointed to two additional one year terms, with the approval of the Director of the Division of Local Government Services in the Department of Community Affairs; and

**WHEREAS**, the Town finds it prudent to appoint an Acting Municipal Clerk for a term of one year who may be re-appointed as Acting Municipal Clerk or appointed as permanent Municipal Clerk upon attaining a Registered Municipal Clerk Certificate; and

**WHEREAS**, the Mayor and Board of Aldermen wish to appoint John P. Schmidt, who it believes possesses the experience necessary and appropriate to perform the function of Acting Municipal Clerk in the highest professional manner; and

**NOW THEREFORE, BE IT RESOLVED** by the Mayor and Board of Aldermen of the Town of Dover, as follows:

1. That the aforesaid recitals be and hereby are incorporated as if set forth at length herein.
2. That John P. Schmidt be and hereby is appointed as Acting Municipal Clerk of the Town of Dover for a term commencing on January 1, 2020 and ending on December 13, 2020.
3. That John P. Schmidt shall be compensated at a starting salary of \$76,666.66 per year prorated on a part time basis of \$23,000.00 per year (which is equivalent to \$442.31 weekly).
4. That John P. Schmidt shall not be eligible to receive Town health, prescription, dental and other benefits according to the eligibility requirements set forth in those plans but only those allowed in the personnel policy of the Town of Dover and those mandated

by law, such as the Defined Contribution Retirement Program.

That John P. Schmidt shall assume all duties and responsibilities of Acting Municipal Clerk as of January 1, 2020.


