ORDINANCE NO. 03-2025

AN ORDINANCE OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF DOVER, COUNTY OF MORRIS AND THE STATE OF NEW JERSEY AMENDING CHAPTER 2-8 OF THE CODE OF THE TOWN OF DOVER TO ESTABLISH THE OFFICE OF EMERGENCY MANAGEMENT

WHEREAS, the Mayor and Town Council (the "Council") of the Town of Dover (the "Town") recognized a need to establish and articulate the functions of an Office of Emergency Management pursuant to Appendix A, Chapter 9, National Defense and other directives of the State New Jersey Office of Emergency Management; and

WHEREAS, the Mayor and Town Council, pursuant to §1-5 and §2-7(B)(1) of the Town's Code (the "Code"), adopt an amendment to Chapter 2, Section 8, to establish and articulate the functions of an Office of Emergency Management as follows:

§ 2-8.2. Office of Emergency Management.

A. Establishment.

- (1) There is hereby established in the Town of Dover an Office of Emergency Management within the Department of Administration. The purpose of this article is to establish rules and regulations regarding the Office of Emergency Management, consistent with Appendix A, Chapter 9, National Defense and other directives of the State New Jersey Office of Emergency Management or the Governor of the State of New Jersey.
- (2) The Office of Emergency Management shall consist of a Municipal Emergency Management Coordinator, Deputy Emergency Management Coordinators (not exceeding 2), an Emergency Management Council, and as many staff positions deemed necessary for proper operation.

B. Appointment.

- (1) <u>Municipal Emergency Management Coordinator.</u> The Municipal Emergency Management Coordinator shall be appointed by the Mayor pursuant to N.J.S.A § App.A:9-40.1 and Directive NJOEM-7 (2022).
- (2) <u>Deputy Emergency Management Coordinator.</u> Deputy Emergency Management Coordinators shall be appointed by the Municipal Emergency Management Coordinator with the approval of the Mayor and Town Council. Whenever possible, Deputy Emergency Management Coordinators shall be appointed from among the salaried officers or employees of the Town of Dover.
- (3) Emergency Management Council. Pursuant to N.J.S.A. § App.A:9-41, the Emergency Management Council shall be composed of not more than 15 members who shall be appointed by the Mayor and shall hold office at the will and pleasure of the Mayor.
- (4) <u>Staff Positions.</u> Staff positions shall be filled by volunteer workforce or shall be appointed in accordance with civil service provisions.

C. Term.

- (1) <u>Municipal Emergency Management Coordinator</u>: (3) Three years.
- (2) <u>Deputy Emergency Management Coordinator</u>: Concurrent to the Municipal Emergency Management Coordinator
- (3) <u>Emergency Management Council member</u>: Concurrent to the Municipal Emergency Management Coordinator or, if appointed from among the salaried officers or employees of the Town of Dover, until his or her concurrent positions terminates.

D. Qualification.

- (1) <u>Municipal Emergency Management Coordinator.</u> The Municipal Emergency Management Coordinator shall be required to meet the local, state, and federal standards pursuant to N.J.S.A. § App.A:9-40.1, Directive NJOEM-1 (2021), and Directive NJOEM-7 (2022).
- (2) <u>Deputy Emergency Management Coordinator.</u> Deputy Emergency Management Coordinators shall be required to meet the same standards required of the Municipal Emergency Management Coordinator.
- (3) Emergency Management Council. Emergency Management Council members shall be appointed from among the residents of the Town of Dover and shall be at least eighteen (18) years of age. Whenever possible, Emergency Management Council members shall be appointed from among the salaried officers or employees of the Town of Dover so as to prioritize intergovernmental coordination and cooperation.

E. Duties.

- (1) Municipal Emergency Management Coordinator. Pursuant to N.J.S.A. § App.A:9-40.1, Directive NJOEM-7 (2022), and the Town of Dover's Emergency Operations Plan, the Municipal Emergency Management Coordinator shall lead the municipal emergency management program and oversee the municipal office of emergency management in accordance with all relevant federal, state, and local laws, regulations, procedures and authorities, including State Directives. The Municipal Emergency Management Coordinator shall be a member and shall serve as Chairman of the Emergency Management Council.
- (2) <u>Deputy Emergency Management Coordinator.</u> Pursuant to N.J.S.A. § App.A:9-40.1 and Directive NJOEM-7 (2022), the Municipal Emergency Management Coordinator shall assist the Municipal Emergency Management Coordinator in his or her capacity to plan, activate, coordinate, and conduct emergency management operations within the Town of Dover.

- Emergency Management Council. Pursuant to N.J.S.A. § App.A:9-41, the local Emergency Management Council shall assist the municipality in establishing the various local volunteer agencies needed to meet the requirements of all local emergency management activities in accordance with rules and regulations established by the Governor in pursuance of the provisions of this act. The local emergency management council is authorized, within the limits of appropriations, to establish an adequate organization to assist in supervising and coordinating the emergency management activities of the local municipality. It shall be lawful for the members of the local emergency management council also to be members of other agencies created because of any emergency. Under the direction of the Municipal Emergency Management Coordinator, members of the Emergency Management Council shall undergo training and obtain certifications as necessary to assist in administering and overseeing the functions and programs described within Directive NJOEM-7 (2022).
- (4) Pursuant to N.J.S.A. App.A:9-43, et. seq., the Town of Dover shall prepare—and submit for State approval—a written Emergency Operations Plan to ensure a regional coordinated response and efficient use of resources.

F. Removal.


- (1) <u>Municipal Emergency Management Coordinator.</u> The Municipal Emergency Management Coordinator shall be removed by the Governor, for cause, pursuant to N.J.S.A § App.A:9-40.2 and Directive NJOEM-7 (2022).
- (2) <u>Deputy Emergency Management Coordinator.</u> A Deputy Emergency Management Coordinator shall be removed, without cause, by the Municipal Emergency Management Coordinator with the approval of the Mayor and Town Council.
- (3) Emergency Management Council. With exception to the Chairman, any member of the Emergency Management Council shall be removed, without cause, by the Mayor.
- (4) <u>Staff Positions.</u> Staff positions shall be removed in accordance with civil service provisions or under provisions of the volunteer contract upon appointment.

ORDINANCE NO. 02-2025

AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE TOWN OF DOVER, COUNTY OF MORRIS AND THE STATE OF NEW JERSEY CREATING RESTRICTIVE PARKING REGULATIONS FOR A PORTION OF UNION STREET & RICHARDS AVENUE

WHEREAS, pursuant to N.J.S.A. 40:48-2.46, the governing body of a municipality may make, amend, repeal and enforce ordinances to regulate vehicular and pedestrian traffic and the parking of vehicles in parking yards and parking places, which are open to the public; and

WHEREAS, the Mayor and Council of the Town of Dover ("Town") recognize that there is a need to make reasonable changes regarding on-street parking on Union Street & Richards Avenue at the request of the Mount Zion Baptist Church, located at 59-61 Richards Avenue ("Church"); and

WHEREAS, the Mayor and Council of the Town also recognize the need for close proximity parking for the aging congregation on Sunday mornings to accommodate those members of the Church who are mobility challenged; and

WHEREAS, the Mayor and Council of the Town have determined that it is in the best interest of the Town to designate an area along-side the church on Union Street & Richards Avenue for "Church Parking by Permit Only" on Sundays between the hours of 8:00am – 1:00pm; and

WHEREAS, the Church will provide parking decals for members of the Church who are permitted to park in this area; and

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Town of Dover, County of Morris, State of New Jersey, as follows:

<u>SECTION 1.</u> <u>Definition – Church Parking Only on Sunday's Between the Hours of 8:00am – 1:00pm.</u>

"Church Parking by Permit Only" between the hours of 8:00 A.M. -1:00 P.M. on Sundays for the purpose of this ordinance shall be an area along the sideline of Union Street & Richards Avenue as identified below that restricts parking during specific hours to allow for permitted Church parishioner's parking only.

SECTION 2. Designation of Restricted Parking Area.

The hereinafter described area owned and used by Mount Zion Baptist Church as a parking area shall be designated as a restricted parking area for church purposes only, between 8:00 A.M. -1:00 P.M. on Sundays, as provided by N.J.S.A. 40:48-2.46: along the westerly curb

line of Union Street beginning at point 34 feet north of northwesterly curb line intersection of Union Street and Richards Avenue, then continuing in a northerly direction for a distance of 73 feet. In addition, this restricted parking zone shall be located along the northerly curb line of Richards Avenue beginning at a point 32 feet west of the northwesterly curb line intersection of Union Street and Richards Avenue, thence continuing in a westerly direction for a distance of 68 feet.

SECTION 3. Area to be Marked with Sign(s).

Mount Zion Baptist Church shall appropriately mark said area with a sign to be approved by the Town of Dover Zoning Department, said sign to contain the words ""Church Parking by Permit Only, Between the hours of 8:00 A.M. – 1:00 P.M. on Sundays"

SECTION 4. Parking Decals.

Mount Zion Baptist Church shall provide parking decals for members of the Church who are permitted to park in this area.

SECTION 5. Violation and Penalties

Every person convicted of a violation of a provision of this Ordinance or any supplement thereto shall be liable to a penalty of not more than fifty (\$50.00) dollars.

SECTION 6. This ordinance shall take effect in accordance with law and shall replace any and all previous ordinances for the described area.

RESOLUTION TO SUPPORT PUBLISHING LEGAL NOTICES ON OFFICIAL GOVERNMENT WEBSITES

WHEREAS, the sunset provision of March 1, 2025, imposed under P.L. 2024 c.106 is fast approaching in what was a temporary solution that allowed local governments to comply with the public notice requirements under the law in time for annual reorganization meetings in January; and,

WHEREAS, local government officials serve as the stewards of property taxpayer dollars and should no longer be required to subsidize the newspaper industry with revenues collected from publishing legal notices in the press; and,

WHEREAS, long before NJ Advanced Media's announcement that it was terminating daily print publications in January of 2025, local government officials found it increasingly difficult to comply with the public notice requirements under the law as the media has become almost exclusively digitized and struggled to retain staff, resources, and publications; and,

WHEREAS, legislation that will authorize local governments to publish legal notices on a local government's official website will streamline an antiquated and overly burdensome process and save valuable time, resources, and property taxpayer dollars; and,

NOW, THERFORE, BE IT RESOLVED that the Mayor and Town Council of the Town of Dover, County of Morris, State of New Jersey do in fact, hereby urge state leaders to pass legislation that will authorize municipalities, counties, school districts, and all local governments to publish legal notices in a clear, transparent, and timely manner on a local government's official website.

BE IT FURTHER RESOLVED that a copy of this Resolution shall be sent to Governor Phil Murphy, Senate President Nicholas Scutari, Speaker of the General Assembly Craig Coughlin, Senator Anthony M. Bucco, Assemblyman Christian E. Barranco, Assemblywoman Aura K. Dunn and the New Jersey State League of Municipalities.

RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF DOVER, COUNTY OF MORRIS, STATE OF NEW JERSEY AUTHORIZING THE AWARD OF A CONTRACT FOR "SAFETYSTICKS", A PARKING / NO PARKING ENFORCEMENT AND PARKING DATA TECHNOLOGY SYSTEM

WHEREAS, Municipal Parking Service, Inc. (PMS) has developed a unique, proprietary, patent-protected Parking / No-Parking Enforcement and Parking Data Technology System referred to as the Sentry System which includes camera equipped, self-enforcing Sentry SafetySticks bollards and the related hardware and the Sentry software that enables operation and web-base back-end management of the SafetySticks; and

WHEREAS, the Town of Dover wishes to deploy up to one hundred (100) SafetySticks and use the Sentry System to monitor parking activity and enforce parking regulations in certain noparking zones such as, but not limited to fire hydrants, bus stops, crosswalks and loading zones in the Town of Dover; and

WHEREAS, the agreement to be executed by the Town of Dover and MPS for the purposes described is annexed hereto and is made a part of this resolution.; and

WHEREAS, this contract is awarded pursuant to appropriate Law of the State of New Jersey specifically but not by way of limitation, N.J.S.A. 40A:111, et seq., including N.J.S.A. 40A:11-5(1) (dd), the exception for proprietary computer hardware and software, as well as any other pertinent statutes appertaining thereto.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Town Council of the Town of Dover authorizes the Mayor and Municipal Clerk to enter into a contract with Municipal Parking Services, Inc., for the aforementioned purpose and
